## The Power of Giving:

## **\$44 Million Granted**

The Community Foundation for Monterey County (CFMC) creates positive, lasting change. Thanks to the generosity of thousands of donors, in 2024 the CFMC granted a record-breaking \$44.4 million, supporting vital programs and services across Monterey County and beyond.

This includes \$11.9 million from the 2023 Monterey County Gives! campaign, \$9.7 million from our donor advised funds, \$1.9 million in Pajaro Community Grants (below), \$1.8 million in scholarships and \$2.1 million in application-based grants, such as our Opportunity Grants program.

Grant recipients Palenke Arts and Youth Arts Collective (see page 4) are just two of many nonprofits empowered by CFMC grants. Thanks to your support, hundreds of organizations continue to uplift our community—especially in challenging times.

Additionally, as we grow the Fund for Monterey County (made up of endowed unrestricted and field-of-interest funds), we are expanding our ability to respond to evolving needs and create a stronger, more resilient future. We deeply appreciate the support that makes this possible and look forward to continuing this powerful work together.

## **Pajaro Community Grants Awarded**

In December 2024, the CFMC distributed nearly \$1.9 million through the Pajaro Community Grants Program. Grants were made possible by California Storm Relief Funds (Assembly Bill 102) allocated by the County of Monterey. We established a volunteer grant committee comprised

of a Pajaro business representative, a County of Monterey representative, County Supervisor Glenn Church and three community residents, including a youth resident, to review applications and provide recommendations. This program awarded grants to 22 organizations to increase the ability of the community to prepare for, respond to and recover from emergencies and natural disasters. The CFMC is producing a report in English and Spanish to share with Pajaro residents outlining the important work that will be done along with the contact information of grant recipient organizations.

Watsonville Wetlands Watch received a Pajaro Community grant to build resilience to climate change. Jonathan Pilch, Executive Director, notes, "Planting trees and installing edible gardens, orchards and native plants creates a healthier learning environment. Increasing the tree canopy cover is a powerful tool to create a healthier environment for the Pajaro community that is resilient to the impacts of climate change and extreme heat."

## **President's Message** Creating Positive Impact

Each Spring this note reflects on a robust year at the CFMC. This means year-over-year gifts and grants continue to grow, fueling our impact. This happened again in 2024. We were the recipient of an amazing \$80 million in gifts and proudly granted \$44 million. Our second year-end Here for Good campaign surpassed year one in its support of the greater work of the CFMC. Never abandoning our core role of building and distributing charitable funds, our work has expanded, and it is very rewarding to see this embraced and supported by our donors.

But at the end of the day, helping to implement the philanthropic vision of our donors, transitioning assets into grants, partnering with a major funder on major projects like the Salinas Inclusive Economic Development Initiative, watching the CNE's LEAD program continue to grow, \$1.8 million in scholarships, all the work at the CFMC is in service to supporting and uplifting the residents of Monterey County. This can be through food programs, the arts, preserving the environment, legal assistance, access to health care...it's a long a list. Every one of these program areas plays an important role in the health and vibrancy of our community.

Perhaps no other program epitomizes the spirit of philanthropy like Monterey County Gives! I'm sincere when I say we make no predictions MC Gives! will continue to grow. However, that's exactly what it does. It crept over \$11 million in 2022. jumped to \$11.9 million in 2023, then skipped over twelve and thirteen, landing on \$14.27 million in 2024. This

partnership between the CFMC, Monterey County Weekly and the Monterey Peninsula Foundation, along with several generous sponsors who provide support to the match fund, has raised and granted \$82 million since 2010, \$54.8 million since the 2020 campaign. While tremendous credit goes to the nonprofits that participate in MC Gives! and their growing expertise at describing their work and encouraging donors to provide support, the real heroes are all of you. MC Gives! is a clear demonstration of the remarkable culture of giving in Monterey County.

2025 is off and running. While I'm sure next year's Spring message will describe a remarkable year, we must acknowledge it is a time of uncertainty for many of our neighbors. The CFMC, its board of directors and staff, remain diligent in our desire to create positive impact.

## MONTEREY COUNTY GIVES!

Joining Together for Big Ideas

Monterey County Gives! 2024 was another recordbreaking success, rallying community support to fund vital nonprofit initiatives across the county. Gives! continued its mission of strengthening local organizations through collective generosity.

This year, the campaign raised \$14.27 million for more than two hundred local nonprofits in areas such as environmental conservation, education, health services, youth programs and social justice. Donations were amplified by matching gifts and challenge grants, inspiring donors to maximize their impact.

In 2024, SIEDI (Salinas Inclusive Economic

Development Initiative) was renewed for another two years through a generous \$3.35 million grant from The James Irvine Foundation. SIEDI Part 2 builds on the original effort by focusing on fostering economic equity and opportunities for historically underserved communities in Salinas.

The initiative works to increase the number of family-sustaining, good jobs in Salinas and strengthen nonprofits and the Community Foundation's ability to engage in inclusive economic development efforts.

SIEDI Part 2 is now in full swing and aims to create long-term economic stability and greater prosperity for all Salinas residents. Partners are collaborating on implementing community-driven economic development practices, identifying current capacity-building needs and opportunities and establishing a shared vision and priorities.

SIEDI is a collaboration between local organizations, businesses and government agencies to create a more inclusive and sustainable economy. The success so far demonstrates the impact that can be made by deep, consistent investment in our community leaders.

MC Gives! continued to highlight the power of community-driven philanthropy, demonstrating how small contributions add up to significant change. Monterey County Gives! once again proved to be a cornerstone of local giving, helping nonprofits expand their reach and improve lives throughout the region.

Monterey County Gives! is a special project of the CFMC, the Monterey County Weekly and the Monterey Peninsula Foundation. Special thanks to Taylor Farms, Neumeier Poma Investment Counsel, Colburn and Alana Jones Foundation of the CFMC, the David and Lucile Packard Foundation, Cannery Row Company, Harden Foundation, Nancy Eccles and Homer M. Hayward Family Foundation, Post Ranch Inn, MST, CFMC donor advisors and two anonymous donors for their generous support of the match.









## **Small Grants - Big Impact**

For over a decade, the CFMC made small (\$5,000) grants to emerging organizations and for one-time, unexpected programs or collaborative opportunities. Most years, the Foundation awarded 10 of these Opportunity grants annually. Due to the COVID-19 pandemic and other factors, applications slowed and there were only three grants in 2023.

The CFMC connected with more than 100 local nonprofit providers for feedback. Responding to nonprofit leaders' comments and concerns, the Foundation combined the Community Impact grants under \$20,000 and Opportunity grant programs. CFMC now accepts Small grant proposals between January and October.

Youth Arts Collective (YAC) received an Opportunity Grant in 2024 for its after-school arts and mentorship program. YAC is a safe space for young artists to grow and learn, serving local youth (ages 14-22) by bridging the gap left by traditional education and home environments. YAC's studio space serves as a sanctuary for creative expression, mentorship and collaboration. Its Executive Director and other staff are alumni of the group, passing on YAC's values of fostering artistic growth, cultivating life skills and promoting emotional well-being.



Youth Arts Collective inspires young artists

YAC serves nearly 80 youth annually, hailing from ten cities throughout the County, of which 68% identifies as LGBTQ+. Through these positive role models, encouragement and a growth mindset, youth are inspired to reach their potential. YAC's mission is "to inspire creativity, kindness, and confidence in our youth through artistic expression and mutual respect. Do art. Be kind."

## Partners in Giving – Giff and Pam Lehman

Giff and Pam Lehman brought their philanthropic journey to life at the February 26, 2025 Legacy of Giving Luncheon. The couple met at the Carnegie Mellon Tipper School of Business. They married after graduation, moved to NYC and raised their family, happily relocating to the Monterey Peninsula in 1997.

They began their partnership with the CFMC in 2016 by creating the Lehman Family Fund, a donor advised fund, in order to simplify their giving. They received an immediate tax deduction and enjoy recommending grants to their favorite causes. "It's just easy. We go online, and don't have to keep track. I know our fund is well-managed," says Giff. (Giff served as a CFMC board member from 2019-2024 and chaired the Foundation's Investment Committee for five years).

Later they were looking for a way to honor — Giff a their long-time nanny, Casilda "Cassi" Paul, who was very involved in her church in Brooklyn and offered her heart and home to many friends and family, before passing away unexpectedly. "She was a real role model for philanthropy," says Pam. "We wanted to do something in her memory."

They created the Casilda Paul Memorial Scholarship Fund in 2021 to benefit children from Cassi's church and have awarded ten scholarships to students in all fields of

study. "The Foundation designed and executed a program that is small but meaningful to us. They truly are our partner in giving," noted Pam.

Giff spoke about their confidence the CFMC will carry out their wishes. "They are uniquely suited to facilitate complex distribution requirements. They are in the inspiring philanthropy business."

They've outlined their legacy giving plans in a Memorandum of Charitable Intent ("MOCI") to keep all their goals in one place. (Learn more below).

Giff shared that when the time comes, "all of our philanthropic assets will flow to the CFMC, including the creation of a donor advised fund for each of our two children. We consider this the gift of giving." For the remainder, they specified that the Foundation grant a percent each year to the charities they selected.

Giff summed it up this way. "We annually

review our MOCI to make sure it still represents our charitable goals. It's easy to change if our vision changes. It can be as complex or as simple as you want it to be. The Community Foundation is just a huge professional resource. They are wonderful thought partners in refining our charitable vision. We have a lot to learn, but we have a great partner."

## **CNE Board Empowerment Program Launches**



Engaged and effective boards of directors are critical to nonprofits' success. In early 2025, the Center for Nonprofit Excellence (CNE) began the Board Empowerment Program, a pilot effort to strengthen the organizational impact of 12 vital Monterey County nonprofits through

effective and empowered board leadership.

This innovative opportunity combines a \$5,000 unrestricted grant with focused consulting, accountability and a learning cohort of other local nonprofits working on similar board projects facilitated by Dr. Lydia Hughes-Evans of Pure Momentum Consulting.

The Board Empowerment Program takes a unique approach in providing structured support to make meaningful changes in board structure, policy and governance. The program aims to embed lasting changes in nonprofits' culture and practices beyond the nine-month program. At its conclusion, the program will harvest the stories of organizational change and share these for the learning benefit of all.

The public launch of the Monterey County COAD (Community Organizations Active in Disaster), an initiative of the Community Foundation for Monterey County, is set for First Quarter 2025, marking a significant step forward in community collaboration and disaster preparedness. Quarterly convenings are scheduled throughout the

year, offering valuable training sessions and readiness opportunities to strengthen local resilience.

In a recent demonstration of coordinated response, Vistra partnered with the Community Foundation to establish the Moss Landing Fire Relief fund to support

households impacted by the January 16, 2025 fire at the Moss Landing Power Plant site. The Monterey County COAD coordinated distribution efforts for residents in the evacuation zone, assisted by partners from United Way Monterey County and the Castro Plaza Family Resource Center. 435 evacuated households received financial assistance via VISA gift cards, distributed over three days, showcasing the power of collective action in times of crisis.
