# Giving Matters



## Strengthening Nonprofits and Communities

Nonprofits are the heart of our communities. In Monterey County they offer vital support and build connections that strengthen us all. Yet many local organizations are facing unprecedented challenges due to Federal policy and funding changes.

The Community Foundation for Monterey County (CFMC) is walking alongside them, through strategic grants as

well as the work of the Center for Nonprofit Excellence (CNE). The new Supporting Our Neighbors Fund assists nonprofit organizations that help individuals facing immigration and policy-related concerns. Grants will fund community outreach, legal assistance, community education about immigrant and LGBTQ+ rights, basic needs and access to mental and physical health services. The THRIVE Grants Program eliminates barriers to success in four key focus areas for local residents (see below).

Guided by survey data and community feedback, CNE's nonprofit programs are designed to meet evolving needs. Recent efforts include a nonprofit gathering of 50 leaders, fostering dialogue and collaboration, as well as ongoing peer learning sessions, consulting and trainings. Topics range from building staff, strengthening fundraising and exploring tools like AI.

As more people ask how they can make a difference, many discover that serving on a nonprofit board is one of the most impactful ways to give back. CNE's Board Ready Training (November 7, 2025) and BoardConnect Program (January 2026) are designed to prepare and connect community members with local organizations ready to partner with them. Together, we can ensure that Monterey County's nonprofits remain resilient, responsive and impactful — today and in the future.

## THRIVE Creating Opportunities for All **THRIVE Grants**

The THRIVE Grant Program was created to address some of Monterey County's most pressing challenges and invest in meaningful, lasting solutions. Rooted in data and shaped by community voices, THRIVE is about removing barriers and creating pathways to success for all residents. In 2024, the CFMC engaged nearly 100 residents in listening sessions, interviewed 25 community leaders and analyzed 15 community reports.

Through this collaborative process, four key focus areas emerged: Housing Stability, Educational Attainment,

Workforce Development and Mental Health Support. By directing funding to these priorities, the CFMC and its funded partners are working to address systemic challenges and create lasting impact.

The first round of THRIVE grants, totaling \$1,332,000 was awarded to 17 local nonprofits tackling these issues. Donors are invited to co-invest in one or more focus areas—or support the broader THRIVE Fund. Together, we can strengthen opportunity and wellbeing for all who call Monterey County home. ## **President's Message** A New Season

I wish I could say there is a slow time of vear at the CFMC. If the calendar was divided into thirds, they would be labeled busy, busier and busiest. We've entered busiest.

We were thrilled to honor Tonya Antle as the 2025 Distinguished Trustee at the Celebration of Philanthropy. Tonya was instrumental in growing the Women's Fund into a force for women and girls in Monterey County. She oversaw the transition of a lightly attended breakfast to a luncheon that attracts 600 attendees. She led the effort to grow a \$2 million Women's Fund endowment. She connected the Women's Fund Scholarship program to Girls' Health in Girls' Hands, the annual awardee of which steals the show with their personal story at the luncheon. As for the Celebration of Philanthropy, it is thrilling to have such an enthusiastic and large gathering of friends and partners in philanthropy.

We are on the cusp of Monterey County Gives! 2025 (in partnership with the Monterey County Weekly and the Monterey Peninsula Foundation). MC Gives raised \$14.2 million in 2024 through 8,000 donors. This support allowed more than 200 nonprofits to deliver on their missions in Monterey County. Gives 2025 will have 217 participants, and potentially a record matching pool. The Challenge Gift phase is underway.

Here for Good supports our ability to deliver programs through the Center for Nonprofit Excellence, nimbly respond to disasters, engage in leadership work on a variety of initiatives and provide a high level of service to our donors and grantees. ## A Lifelong Journey of Giving **David & Marylu Mesa**

For David and Marylu Mesa, philanthropy is a way of life. "We've always been givers," says David, who grew up in San Juan Bautista and enjoyed a long finance career in local government, including the Counties of Monterey, San Benito and Napa. Marylu, originally from Palo Alto, was an ESL instructor at Gonzales High School and Hartnell College, where the two met at a community wine tasting class.

Inspired by parents who modeled generosity, David and Marylu began their giving journey through volunteer service. David served on the Board of Directors of the Pajaro Valley Community Health Trust and volunteered with the United Way Tax Assistance program. In 2012, David was one of six individuals nominated for the Jefferson Award for his community service.

Marylu volunteered her talents with the boards of Soroptimist International of Salinas and the Arts Council for Monterey County and has served as an officer for Delta Kamma Gamma Society, a professional society of women educators, at the local, regional and state levels. The couple both served on the Girls, Inc. Board of Directors and were honored for their impact. They currently support the Read to Me Project.

As their financial capacity to give grew, they established a donor advised fund in 2011, allowing them to simplify giving and support causes they care about—especially education and youth—using both appreciated stock and cash donations. They receive tax deductions at the time of the gift, and the ease of giving over time. It was also at this time they learned the benefits of giving through the Monterey County Gives! campaign. Marylu stated, "MC Gives! is a great way to facilitate our year-end giving."

When Marylu took her first Required Minimum Distribution (RMD) at age 70 ½, they paid taxes before donating a portion to various local nonprofits. The next year, they began taking advantage of IRA Qualified Charitable Distributions (QCDs), a tax-wise strategy that maximizes charitable impact by donating directly to their favorite nonprofits.

Today, they use their IRA to both support individual nonprofits and Monterey County Gives!, allocating gifts to their favorite organizations, which receive a partial match through the campaign. David and Marylu are thoughtful, engaged philanthropists who model the power of careful gift planning.

## **Caring for Community – Post Ranch Inn**

At the iconic Post Ranch Inn in Big Sur, community is more than a concept—it's a way of life. For co-founder Mike Freed and Vice President of Operations Mike Higgins, hospitality isn't just about creating a world-class experience for guests—it's about cultivating a deep sense of belonging and giving back.

"The instinct at the Ranch has always been to care—for the land, for our staff and for the community," says Freed (who refers to himself and Higgins by last names to differentiate among the many Mikes on property). Both men speak glowingly of the Post Ranch culture rooted in connection, stewardship and purpose.

"Community is critical to what we do," says Freed. Both he and Higgins helped open the Ranch in 1992, and describe the Ranch as a large family—one where staff, guests and community members are all greatly valued.

Post Ranch Inn's leadership exemplifies and encourages staff volunteerism, from trail-building to serving in the

Big Sur Fire Brigade and local schools. The team also provides subsidized housing for 70 staff and families.

To consolidate their giving, the Ranch established the Post Ranch Inn Big Sur Community Fund at the CFMC (the "Big Sur Fund") in 2023. Post Ranch contributes \$25 per occupied room per day throughout the year (plus owner contributions).

Grants support local nonprofits like the Big Sur Health Center, Ventana Wildlife Society, Big Sur Volunteer Fire Brigade, the Fire Wise Safety program, Community Association of Big Sur, the Big Share and disaster relief. Post Ranch also

contributes to the overall match and individual nonprofits through Monterey County Gives!.

"Philanthropy is not just giving money to nonprofits. It's volunteerism and how businesses engage with the community to make it better," says Freed. Read more: cfmco.org/PostRanch.

## Celebrating the Power of Community in Carmel Valley

On Thursday, August 28, 2025, friends, neighbors and supporters gathered at Hidden Valley Music Seminars to celebrate the growing impact of the Community Fund for Carmel Valley (CFCV). Peter Meckel, CFCV Advisory Council member and the Founder and General Director of Hidden Valley Music Seminars, spoke about the importance of investing in community well-being.

Ashley Solano, a young Carmel Valley resident whose life has been touched by the CFCV, shared her story of

resilience and opportunity. She is a Cachagua Fire Protection District volunteer who is pursuing a career in emergency and anesthetist nursing, while attending college classes and volunteering at CHOMP. Her path illustrates how donor support empowers young people to pursue their education, enables nonprofits to expand their impact and helps the entire community thrive.

Since its founding in 2020, the CFCV has become a trusted resource for local philanthropy. They have granted \$320,000 including \$188,000 for fire relief and recovery and \$27,000 for flood relief. They are also building an endowment exceeding \$150,000—a permanent fund dedicated to meeting community needs for generations to come. ## Pajaro Grant Brochures Distributed

In December 2024, the CFMC launched the Pajaro Community Grants Program to strengthen the community's ability to prepare for, respond to and recover from emergencies and natural disasters. More than \$1.8 million was granted to 22 organizations dedicated to serving Pajaro residents. "These funds were meant for Pajaro, and the CFMC is proud to say the Pajaro community decided how they were used," shared CFMC Director of Community Initiatives and Partnerships Michael Castro.

In August 2025 the Monterey County COAD (Community Organizations Active in Disaster) distributed bilingual informational booklets highlighting each grant recipient's project and key contact information so Pajaro residents can easily access available support.

## Maximize Year-End Giving

As 2025 draws to a close, now is an ideal time to align your charitable giving with your financial goals.

The CFMC offers several tax-wise strategies—like Donor Advised Funds, IRA Qualified Charitable Distributions (QCDs), appreciated stock gifts and life-income gifts—that can support the causes you care about and deliver potential tax advantages.

To ensure your gifts count for the 2025 tax year, important deadlines apply. To recommend grants

from your Donor Advised Fund (DAF), the deadline is 9 a.m. on December 22. New DAFs can be established through December 31. IRA QCDs must clear your custodial account by December 31, but should be initiated by December 10 to ensure timely processing.

Remember, year-end gifts through Monterey County Gives! from November 13-December 31, 2025 receive a partial match (see page 4).
