Recent OD Grant:

- A human services nonprofit built its **fund development and donor stewardship infrastructure**. OD funds were used to purchase one year of a two-year subscription to DonorSearch. The software enabled staff to use wealth screening tools and giving patterns to identify high potential donors within its current donor database. Staff also learned to develop individualized stewardship plans. Outcomes were reflected in strong success in Monterey County Gives campaign during a time of economic instability and donor giving uncertainty.

Organizational Development (OD)

Strong proposals meet eligibility requirements and

- Demonstrate a **vision for organizational growth**
- Clearly **describe what will be different** about the organization as a result of the project and how success will be measured.
- Include realistic budgets that demonstrate comprehensive support for the project's success.
- Detail a **plan that makes sense** with the necessary financial and human resources for implementation.
- **Leaders take an active role** and are guided by assessment, feedback, learning and improvement.

Timeline

- March – Grants awarded and Zoom orientation for cohort
- April – Action plans identified
- April to January – Monthly coaching with Coral Collective consultants (Allie Ladio and Corinne Enni)
- Dates TBD – two in-person cohort convenings for support and shared learning
- February 2027 – Grant evaluation report due

Participation: Executive Director and Board Chair teams.

CFMC does not prohibit the use of AI with its application-based grant forms. If grantseekers use AI tools to prepare their grant proposals, CFMC encourages the following:


- **Proofreading the proposal/report before submission;**
